Admission Requirements

The following are required by Wetaskiwin Air Services Ltd. to process your application for admission:

1. Demonstrated proficiency of the English language.
2. Ability to obtain a Canadian Aviation Medical at the standard for the license being sought.
3. Proof of sufficient funds including anticipated living expenses.
4. Must be 18 years of age.
5. Must be able to meet the eligibility requirements for Visa to enter Canada as a student.

How to Apply:

To apply for entry into any program you must complete an application for admission and submit it to Wetaskiwin Air Services Ltd. with a \$2000 CDN application fee and proof of admission requirements as listed above. The application fee will be held on account and applied against the program fees.

Start Your Training:

We accept admission to our programs through out the year, however we recommend starting some programs in March to take advantage of summer weather to complete the basic training programs.

Payment of Fees:

Payment for training is made from moneys held on account with Wetaskiwin Air Services Ltd. Students must maintain a minimum level of \$1000 CDN in their account until training is completed. Payment must be made before training can begin. Payment can be made in cash, travelers cheque, Visa, Mastercard, Debit Cards or bank cheque made payable to Wetaskiwin Air Services Ltd. Bank cheques must clear the bank before being accepted for payment. Bank cheques can take up to 10 days to clear, therefore to help avoid delays in training payment by cheque should be by certified, cashier or official bank draft.

Refund Policy:

If a student withdraws from the program within three days of and initial introduction and tour of our facilities, all monies paid on account will be refunded less a \$250 administrative fee. After commencing training any unused portion of the money on account will be refunded less a \$500 administration fee for those students withdrawing voluntarily and \$1000 fee for those students who are expelled from the program. Expenses for training, books and training supplies, no show fees and examination fees will be itemized. Credit for books returned in unused, unopened and unmarked condition and with direct proof of purchase may be granted.

Accommodations:

Wetaskiwin Air Services Ltd. can provide assistance in finding suitable accommodations prior to arrival. Please notify us as soon as possible if you need our assistance.

Code of Conduct:

All students will be expected to abide by the Wetaskiwin Air Services Ltd. Code of Conduct for Students. Failure to do so may result in expulsion.
